ORDER:-

In the circumstances reported by the then District Collector, Chittoor and the Spl. Chief Secretary & CCLA, A.P. in the reference 1st and 2nd read above, Government have issued orders in the reference 3rd read above, constitution of Committee headed by District Collector, Chittoor, to submit detailed proposals regarding the criteria to be adopted for allotting house site plots. In the reference 4th read above the then Collector, Chittoor has submitted a proposal in this regard. In the reference 5th read above, Government have issued orders approving the report of the Committee constituted in the reference 3rd read above, for regularization of land in Settipalli Village of Tirupati Urban Mandal, Tirupati Division, Chittoor District (the then).

2. In the reference 6th read above, Government in Panchayat Raj & Rural Development, have issued orders de-notifying the areas of Settipalli Gram Panchayat Viz., 1. Settipalli, 2. Settipalli Harijana Wada 3. CRS Quarters 4. Upparapalem and 5. Vinayaka nagar, for merging the same into Tirupati Municipal Corporation, Tirupati District.

3. In the reference 7th read above, Government in MA&UD (G) Department have issued notification by altering the limits of Tirupati Municipal Corporation by including the Settipalli, Settipalli Harijanawada, CRS Quarters, Upparapalem and Vinayaka Nagar Habitations of Settipalli Gram Panchayat of Tirupati District.

4. In the reference 8th read above, the Commissioner of Tirupati Corporation among others have requested the Government that the process of creation and further development of plots may be ordered to be taken up by Tirupati Municipal Corporation instead of TUDA subject to the allocation of funds by Municipal Administration & Urban Development Department in view of the inclusion of the habitations of Settipalli Gram Panchayat in Tirupati Municipal Corporation limits.

Government, after careful examination of the matter and as concurred by the Finance Department, hereby modify the orders issued in G.O.Ms.No.173, Revenue (EA&AR) Dept., dated:15.2.2019, substituting Tirupati Urban Development Authority (TUDA) with Municipal Corporation of Tirupati, as Executing Agency, since Settipalli Village has now been merged with Municipal Corporation of Tirupati.

6. The Chief Commissioner of Land Administration & Spl.CS, A.P. and the Collector, Tirupati District shall take necessary further action accordingly in the matter.
